APPROVAL OF UNIVERSITY PARKING FOR FY 2008

Action Requested: Consider approval of the proposed annual parking rate increases at the three Regent universities and changes to UNI's Parking Manual as detailed in the attachments.

Details for each university, including justification for the proposed increases, information on bond indebtedness, recent improvements, and long-term plans for each parking system are included in Attachments A, B, and C.

Executive Summary: Each university has parking systems that are self-supporting. User fees and fines support operation, maintenance, and capital improvements. The parking systems do not receive any state appropriated funds.

Parking rate increases and changes to UNI's Parking Manual as illustrated on pages 2-10 were first presented to the Board for consideration in March. No changes have been made since March. The following approvals were requested for FY 2008:

- ◆ University of Iowa annual charges would range from \$50 - \$1,920;
- ◆ Iowa State University annual charges would range from \$38 - \$734; and
- ◆ University of Northern Iowa annual charges would range from \$21.50 - \$336 and several penalties and fees would increase.

Background: The Board gives preliminary consideration to the parking system rates and manual changes in March and final approval in May.

Iowa Code Chapter 262 allows the Board to make rules regarding policing, control, and regulation of traffic and parking on the property of any institution under its control. It also requires notification to students 30 days prior to action by the Board to increase charges or fees at the universities. Notification of the proposed parking rate increases has been mailed to the student government president at each of the universities.

Each university has a:

- ◆ Manual that contains rules and regulations for parking on campus and includes information such as vehicle registration, parking permits, and fees and fines.
- ◆ System that provides many services including patrol, maintenance, repair, snow removal, resurfacing, construction, as well as meters, signage, salt/sand, equipment, and supplies.
- ◆ Committee that oversees parking operations and proposes changes to parking and traffic regulations as well as fees and fines for their comprehensive parking program.

UNIVERSITY OF IOWA

Nearly 15,400 parking spaces are available for visitors, faculty, staff, and students, an increase of 745 since February of 2006.

Outstanding bond indebtedness on the University of Iowa parking system as of June 30, 2006, totaled nearly \$26.8 million.

This is the third year of a multi-year rate increase (see page 4). The University proposes one new permit and increases to its published parking rate schedule, effective July 1, 2007, for hourly, metered, and cashiered rates, and August 1, 2007, for all annual and temporary rates.

The new Night and Weekend (NW) permit is for non-permit holding faculty, staff, and students. It allows for closer parking in the evenings and on weekends, improves safety, and encourages alternative daytime commuting options.

Annual charges for FY 2008 would range from \$50 - \$1,920 and are illustrated in the table on the following page. No increases to parking violations and no changes to the parking manual are proposed.

The University reports that demand for parking continues to grow significantly while capacity declines due to campus development. The University explains that the growth is a result of employee transportation choices, increased student demand as gas prices decline, increased use of cashiered facilities serving patients, and requests for motorcycle and motor-scooter permits.

Over the last year, the University has:

- ◆ Completed the 599-space Melrose Avenue parking ramp south of the Field House, which opened in December 2006;
- ◆ Completed reconstruction of Kinnick Stadium, which opened up several hundred displaced spaces and moderately expanded parking capacity for UIHC employees;
- ◆ Implemented the Physician's permit, which allows 100 faculty-clinicians to park adjacent to UIHC or the Carver College of Medicine;
- ◆ Expanded the number of spaces leased from the City of Iowa City to 467;
- ◆ Continued to accommodate peripheral parking facilities with Cambus, the University bus system that transports people to work sites free of charge. (Cambus service links nearly 7,000 parking spaces in peripheral lots to the center of campus. During FY 2007, Cambus provided more than 24,000 hours of service);
- ◆ Managed commuter programs such as van and car pools and discounted bus passes for the Iowa City and Coralville transit systems. Van pool participation reached an all time high of 788 members during 2006, and included a gain of 260 participants over 2005. The University reports that increased participation in these programs moderates parking rate increases by reducing demand;
- ◆ Installed a proximity card access system to control parking gates at 25 facilities, which permits greater flexibility, better monitoring, and provides better off-peak utilization; and
- ◆ Created an on-line waiting list for faculty and staff, which simplifies the process to update preferred parking options and reduce the number of phone calls to parking services employees.

IOWA STATE UNIVERSITY

Nearly 18,800 parking spaces are available for visitors, faculty, staff, and students on campus. Outstanding bond indebtedness on the ISU parking system as of June 30, 2006, totaled nearly \$5.5 million.

The Department of Public Safety's Parking Division primarily manages ISU campus parking operations. The Memorial Union manages the Memorial Union Ramp. Functions between ISU and the Memorial Union are coordinated, but have separate operations and fee structures.

Over the last year, ISU constructed two new lots, renovated two lots, improved two parking areas, and completed its fourth year of project to seal-coat existing asphalt lots; approximately 40,000 square yards of asphalt were seal-coated during 2006. One of the new lots was constructed in conjunction with faculty at the Center for Transportation Research and Education. ISU plans to continue its work to construct environmentally sensitive parking facilities.

As a result of changing campus expansion priorities, new campus growth projections, and additional data gathered from studies, ISU reports that they plan to gather information including viability, location, and size of a potential west campus parking facility.

The University proposes increases to its published parking rate schedule. Annual parking rates for FY 2008 would range from \$38 to \$734 and hourly charges for the Memorial Union parking ramp would range from \$0.25 to a maximum of \$8.00 daily. The University reports that additional revenues generated from the proposed increases will be applied to maintenance, rehabilitation, and the upgrade of existing parking lots.

No changes to University parking regulations are proposed. The University states that the goal of last year's increase in parking fines was to gain greater compliance. ISU reported a 20% decline in written citations and anticipates that it will further decline and result in reduced revenues from fines.

The University reports that University Family Housing is now known as Schilletter and University Villages (SUV) and proposes to update its parking manual to reflect this new designation.

The University reports that the Memorial Union Ramp's \$3.4 million renovation included structural improvements, installation of a new revenue control system, and a new striping plan. The Memorial Union is in the process of changing from a personnel-staffed operation to an automated system which will expedite departure time, capture revenue 24 hours a day, reduce labor costs, and improve internal controls.

UNIVERSITY OF NORTHERN IOWA

There are 8,300 parking spaces available on campus for visitors, faculty, staff, and students. UNI has no outstanding bond indebtedness on its parking system.

The University proposes increases to its published parking rates, effective August 1, 2007, and modifications to UNI's Parking Manual, including increases to penalties and fees, and text revisions (see page 10).

The University reports that additional revenues generated from the proposed parking increases will be applied to ongoing operational costs, continued maintenance/repair of current parking areas.

In addition to basic lot repair and maintenance, a parking lot was added next to the new Business and Community Services building during the past year.

The long-range parking plan had previously included a Multi-Modal Parking Facility (MMF), which has been scaled down to a parking deck with expanded bus service and some additional parking. The University reports that construction of the deck could begin in the Fall of 2007.

WORDING REVISIONS

The University reports that:

- ◆ Section 2.4 is being modified to reflect the addition of the pre-tax option for parking permit deductions.
All parking permit applicants wishing a two (2) period payroll deduction must apply no later than September 15. Faculty and staff purchasing the G, A or B parking permit are eligible to have their permit fee deducted on a monthly pre-tax basis. The enrollment deadline is August 15.
- ◆ Section 9.2 is being modified to state that parking tickets for illegal parking may be issued once per every eight hour shift. The University reports that it is not always a full eight hours between tickets issued by different shifts.
Parking tickets for illegal parking may be issued once per every eight (8) hour shift.
- ◆ Section 9.6 is being modified to include the Iowa Administrative Procedures Act to be more descriptive.
Appeals will be accepted in oral or written form by the Appeals Committee. The decision of the Appeals Committee shall be final, but may be heard de novo by the District Court as prescribed by Iowa Administrative Procedures Act 17a law.
- ◆ Section 12.6 is being removed because it is redundant and gives faculty, staff, and students the impression it is allowable for them to use the metered visitor lot.
~~Parking permits are available by making application at the Department of Public Safety. Persons with or without a parking permit are eligible to use the metered parking areas.~~
- ◆ Section 12.6 is being renumbered.
Parking lots may be temporarily closed to facilitate cleaning, maintenance or other university purpose. Parking lots may be temporarily reassigned or restricted in the case of special events on campus.
- ◆ Section 12.7 is being modified to make service permits available to vendors and University departments.
Service permits are available to vendors and University departments for an annual fee of \$118.00 effective August 1 through July 31.
