AGREEMENTS WITH THE NEBRASKA DEPARTMENT OF EDUCATION

Action Requested: Consider approval of the agreements with the Nebraska Department of Education as summarized below.

Executive Summary: Academic Year Agreement – Renewal of the education services agreement with the Nebraska Department of Education for FY 2017 at the rate of \$93,267 per Nebraska student (\$56,199 for educational and related program services and \$37,068 for residential services as necessary) – giving a decrease of \$1,024 (-1.1%) for combined services. Costs vary by projected budget and number of students.

In May 1998, the Board of Regents and the Nebraska Department of Education entered into an agreement for the Iowa School for the Deaf to provide educational services to Nebraska students with hearing impairments. The agreement was modified on September 9, 2010 to base costs on projected budget and the number of Iowa students. This educational arrangement has been working well for both ISD and Nebraska since FY 1999. The agreements allow for renewal by mutual consent and written notification by both parties. Currently, 11 Nebraska students are enrolled at Iowa School for the Deaf (9 residential and 2 academic only). For FY 2017, ISD projects an enrollment of 10 Nebraska students (8 residential and 2 academic only).

Last year, both parties provided intent notice to renew this agreement for FY 2017. ISD and the Board Office recommend that the contract be renewed for FY 2017 with the new tuition rate of \$56,199 and the room and board rate of \$37,068 for a combined charge of \$93,267 per student. The Nebraska Department of Education has received the proposed rates and will take action at its next meeting.

Summer School Agreement – Renewal of the Nebraska Summer School agreement for the summer school program of 2016 with a weekly charge of \$555 per Nebraska student (2.2% increase); \$283 for educational and related program service and \$272 for residential services.

The academic year agreement between the Board of Regents and the Nebraska Department of Education specifically excludes services related to the summer school program.

In May 1999, the Board approved an agreement for the Iowa School for the Deaf to provide summer school programming for Nebraska students with hearing impairments. Iowa School for the Deaf generally offers a multi-week summer school program, and students may attend as many weeks of the program as available. Because of the manner in which the ISD summer program is operated with activities well past the evening meal hour, it is preferable that students be in residence during the week(s) that they participate in the summer program.

Both Agreements – Notification of the Board's intent to renew each agreement with the Nebraska Department of Education for FY 2018, pursuant to the provisions of the agreements.

It is recommended that the Board, on behalf of the Iowa School for the Deaf, notify the Nebraska Department of Education of its intent to renew the agreements for FY 2018.
