OPENING REMARKS

Vice President for Medical Affairs Dr. Jean Robillard provided opening remarks to the Committee.

He: (1) said that the Board will be asked later in the day to approve the naming of the University of Iowa Children's Hospital the "Stead Family University of Iowa Children's Hospital" in recognition of Jerre and Mary Joy Stead's \$25 million gift commitments to advance children's medicine; and (2) expressed gratitude to the Steads for what they have done and what they continue to do for children's programs in the state and said the impact of their gift will continue to be enormous for all children in the state of Iowa as well as the rest of the country.

He also reported the Dance Marathon Committee recently awarded \$2.2 million over the next three years to the University of Iowa children's pediatric oncology program to begin hosting phase one and phase two clinical trials. Over 2,500 students raise money every year to help solve pediatric cancer. Dance Marathon started in 1994 and has raised over \$16.5 million dollars in the last 21 years.
