Reports from Institutional Heads

Presidents Wilson, Wintersteen and Nook delivered updates on their respective institutions.

Fall Enrollment Report

President Richards recognized Board of Regents Associate Chief Academic Officer Jason Pontius, who presented the Fall 2023 Enrollment Report. Pontius noted that enrollment increased by 302 students from Fall 2022 to Fall 2023.

Economic Development and Technology Transfer Report

President Richards recognized Board of Regents Senior Communications Director Josh Lehman, who introduced UI Director of Corporate Engagement Jeff Kueter, Senior Director of UI Ventures Jordan Kaufmann, ISU VP for Economic Development and Industry Relations David Spading, and UNI Executive Director of Business and Community Services Randy Pilkington to present institutional economic development reports.

Diversity, Equity and Inclusion Study Group Report and Recommendations

President Richards recognized Regents Barker, Lindenmayer and Rouse, who presented their recommendations as the Diversity, Equity and Inclusion Study Group.

Regent Dunkel thanked those who worked on the report for their work. Dunkel noted some definitions of DEI apply to her, personally, and that she may not have been able to participate as a Board member had it not been for DEI policies. She disagreed with some of the points described in the group's recommendations. Regent Dunkel asked the study group if there were specific numbers in the DEI survey that would spur change; what numbers influenced them to make their recommendations; and if any of the recommendations are tied to specific questions on the survey. Lastly, Dunkel noted that, in her opinion, recommendation 8 seems to expand DEI practices, but only for selected groups.

Regent Lindenmayer disagreed with the idea that the recommendations would inhibit DEI intentions. Lindenmayer noted that the recommendations were "sufficiently vague" in order to give the institutions the flexibility to serve their students and address their legislators.

Regent Barker noted that the DEI survey was not intended to be a scientific survey, but rather a collection of different perspectives. With regard to Regent Dunkel's question on recommendation 8, Barker said the recommendation does not create new DEI structures, but rather asks the universities to think about their hiring practices with regard to diversity in philosophical perspective.

Regent Bates asked Regent Lindenmayer if it was fair to say that the recommendations allow the universities to work within their own frameworks. Regent Lindenmayer agreed with Regent Bates's assertion.

Regent Cramer asked the study group if removing DEI programs makes the institutions less welcoming places. Regent Barker noted that any bureaucracy that grows over the years needs to be analyzed by governing boards. Regent Rouse stated that the recommendations have no impact on student-run groups.

Regent Crow asked if there were examples of DEI services that were not provided to all students. Regent Barker noted that there are several programs that are open to all students by policy, but are perceived to be available only to certain groups of students.

Regent Crow asked how having a DEI hiring statement would negatively impact a student or applicant. Regent Barker noted that the recommendations make it clear that the universities would not have DEI tests for admission. Regent Crow replied that as an applicant to the UI Nursing program, she would work with patients from a range of backgrounds and experiences and that understanding proper and equitable healthcare practices is imperative, as is allowing the universities to evaluate their applicants based on this understanding. She asked how the universities could maintain their recruitment strength without this component. Regent Barker answered that the DEI Study Group recommendations do not affect curriculum. Regent Lindenmayer noted that the recommendations do not bar DEI statements.

Regent Bates asked if recommendation 8 was redundant and requested more information. Regent Crow noted that she thought recommendation 8 stood in opposition to the rest of the recommendations. Regent Barker said he believes that the universities have experienced a

decrease in diversity of philosophical perspective over time and that he believes that kind of diversity is beneficial and has been neglected. Regent Crow stated that cutting other aspects of diversity while promoting diversity of philosophical perspective seems counterintuitive. Regent Barker noted that the universities have done an excellent job at promoting diversity but have fallen short on diversity of ideological perspective. Regent Crow stated that she doesn't believe the Board can pick and choose which areas of diversity to promote and which areas to cut.

Regent Cramer asked how the recommendations would be implemented by the universities. Regent Barker noted that the study group hasn't established any formal guidelines, but that the group would work with the universities. Executive Director Braun stated that the Board Office staff would work with the universities, as well. President Richards noted that the study group would be dissolved following the report.

Regent Barker submitted and withdrew a motion to consider the four remaining recommendations together. The Board agreed to discuss and consider the remaining recommendations individually.

Regent Crow stated her concerns about the efficiencies the recommendations looked to achieve, noting the universities were already efficient with regard to DEI services compared to their peer institutions. Regent Barker remarked that several institutions with much larger research budgets than lowa's public universities spend comparatively less on DEI, so efficiencies can still be found while still maintaining accreditation.

Regent Dunkel stated that pairing back DEI initiatives to the bare minimum wasn't good enough and in her opinion the Board could do better.

President Richards stated that since the Board would turn the recommendations back to the universities for implementation, the adopted recommendations did not have to mean drastic cuts. Regent Lindenmayer agreed and expressed faith in the institutions.

Regent Crow stated that she has heard from numerous students in opposition to the recommendations and as the student regent cannot support the recommendation.

X MOVED by CROW, SECONDED by DUNKEL to amend recommendation 8 to read: Annually the Board Office will issue a reminder of the commitment for the recruitment of candidates with the diversity of intellectual and philosophical perspective in faculty and staff applicant pools.

Regent Cramer noted that the original language of the recommendation asked the universities to explore strategies for recruitment. He stated he would vote no on the amendment and support the original language.

Regent Barker stated the original language compels the universities to explore possible methods for increasing philosophical diversity and that he would vote against the amendment.

Regent Crow explained that her amendment removes the contradiction between recommendation 8 and recommendations 1 and 2 and highlights the Board's commitment to ensuring equal support to all across campus without valuing certain perspectives or identities more than others.

Regent Dunkel stated that the original recommendation 8 is not measurable, and that she supports the amendment, in part, because it is measurable.
