APPROVAL OF ACADEMIC AND ADMINISTRATIVE FEES FOR 2011-2012

Actions Requested:

- ◆ Approve, as a second and final reading, proposed revisions to Chapter §8.04 as shown on page 2; and
- ◆ Approve the proposed fee changes for the 2011-2012 academic year as shown on pages 3 – 7.

Executive Summary: Board approval is required prior to implementation of all fees.

At its February meeting, the Board:

- ◆ Considered, as a first reading, the proposed revisions to Chapter §8.04 (Miscellaneous Fees) as illustrated on page 2; and
- ◆ Received the report on proposed Academic and Administrative Fees for the 2011 – 2012 academic year.

One additional change is being proposed since February's presentation. The University of Iowa requests the Board's approval to eliminate one administrative fee: Career Services Fee – By College – Education – Ten Additional Sets of Credentials. The University reports that it no longer charges this \$10 fee.

Background:

Regent Policy Manual §8.04:

- ◆ Requires that the Board review and approve all new institutional or college-wide fees over \$1 per semester and all departmental fees over \$10 per semester; and
- ◆ Encourages the three universities to work together to establish common titles and amounts for fees. The Board Office and university personnel will continue efforts to reduce the number of fee categories. Some differences in fee titles and amounts may remain because of the unique nature of some programs and services at each institution.

Iowa Code §262.9(18) requires the Board to take action no sooner than 30 days after notification of the proposed fee changes to presiding officers of each student government organization at each affected institution. Written notification of the proposed fee changes was mailed to the student government president at each of the universities on January 31, 2011.

Iowa Administrative Code §681-1.7 requires that application fees be modified through the Iowa Administrative Rules process. No changes to application fees were proposed.

Chapter 8.04 – Miscellaneous Fees Academic and Administrative Fees

A. Consistency Among Universities

The three universities are to continue to work together to establish common titles and charges for miscellaneous academic and administrative fees.

Some differences in fee titles and charges may remain because of the unique nature of some programs and services at each institution.

B. Institutional or College-Wide Fees

Board approval is required for:

- ♦ All new institutional or college-wide fees.
- ♦ All institutional or college-wide fees of over \$1 per semester and all departmental fees over \$10 per semester.

These fees do not include course fees for payment for materials used, fees that represent returnable deposits, fees assessed for damage or breakage by individual students, and fees assessed to pay for services external to the university.

~~C. Student Organization Fees~~

~~The Board approves the concept of a negative checkoff system (opt-out funding) for a student organization financed by nonmandatory student fee collections for the University of Northern Iowa.~~

~~The Board approves the concept of a positive checkoff system (opt-in funding) for students to a student organization financed by nonmandatory student fee collections for the State University of Iowa and Iowa State University.~~

~~*Rationale: Student organizations are funded either through Student Services or Student Activities Fees. The check-off option is no longer utilized.*~~

~~D. Types of Miscellaneous Fees~~

~~1. Tuition related~~

~~Tuition-related fees include items such as continuing education courses and workshops. The tuition-related fees are presented with the Board's annual discussion of tuition and mandatory fees.~~

~~2. Non-tuition related~~

~~Non-tuition-related fees include a variety of items such as course delivery fees and private music lessons. In each category, students pay only the miscellaneous fees and charges that apply to them, with variances, in type and amount dependent on each student's program, needs, and interests. The non-tuition-related fees are presented in the spring timeframe when the Board discusses room and meal rates.~~

C. Types of Academic and Administrative Fees

Fees are categorized as either academic or administrative. Students pay only the fees that apply to their programs, interests, or needs.

- ♦ Academic fees include items such as Extension Courses, Continuing Education, and Workshops; Dentistry Fees; and Applied Music Fees.
- ♦ Administrative fees include items such as Application, ID Card Replacement, and Graduation Fees.

Academic and administrative fees are presented with the Board's annual discussion of tuition and mandatory fees. These fees may be brought to the Board for revision following initial adoption should the actual costs differ from the original estimates.
