President Richards read a statement:

Presidents Harreld and Wintersteen met with the Board of Regents leadership, each university's legal counsel and the university chiefs of police to discuss the investigation of allegations relating to the University of Iowa Band from the September 14, 2019 Iowa - Iowa State football game. Following the investigation it was determined there was not enough evidence available to substantiate the pursuit of any charges. All three university presidents have agreed to work together to review and improve game management policies for games

on each of our campuses prior to the start of the 2020 fall semester. These efforts are underway.

Each of our schools has made a commitment to continue to make safety at our games a priority. We want to be able to provide a safe environment for everyone and don't want to feel unsafe at any of our events. We applaud the efforts of all three schools to come together and implement protocols to that end.
