## **Board President Report**

President Richards read a statement:

In her Condition of the State address last month, Governor Reynolds announced an effort to improve state government by aligning departments differently and making operations more efficient.

There are two areas that I want to address that affect the Regents Enterprise. The first is moving the Governor's Iowa STEM Council from the University of Northern Iowa to the state's Department of Education.

Governor Reynolds is co-chair, and there are countless people involved in this critical initiative. From the executive committee, the advisory council, regional network managers, operations staff, and various programs, this program continues to build a strong STEM education foundation. UNI has done an amazing job in building this capacity for the state of lowa.

Changes to funding, programming, and operations are not expected. In fact, we are hopeful that programming may expand. The responsive STEM programming for young people and in local communities will continue.

The second thing I want to mention is governance of the Iowa School for the Deaf and Iowa Educational Services for the Blind and Visually Impaired. Governor Reynolds recommends moving oversight of those two entities, also to the Department of Education.

The Governor's proposal will streamline administrative efforts to make decisions for all K-through-12 students within one department. The D.O.E. already oversees K-through-12 education statewide, including those with disabilities, and has the expertise and background to add oversight of ISD and IESBVI. Our special schools already work closely with many D.O.E. and A.E.A. staff in their day-to-day work. This alignment makes sense, and will serve our deaf, hard of hearing, blind and visually impaired students well.

The Board of Regents wants what's best for the students and families that receive services through ISD and IESBVI. Everyone should know that existing programs and

services will continue; no services will be cut, and no employees will be laid off because of this proposed realignment.

This process is just getting started, so no changes are imminent. It will take time to go through the legislative process, and the Board will work with all stakeholders to ensure a smooth transition as things move forward.

We have solid leadership in place with Interim Superintendent John Cool. The Board has full confidence in him to assist with the transition.

In conclusion, let me also say that we know people are very anxious for news on a search for a permanent superintendent. We must pause on that for now, while the governance and oversight are addressed.

Chief Academic Officer Rachel Boon introduced the provosts to share rationale on changing peer institutions for Iowa's public universities.
