# **INSTITUTIONAL AND BOARD OFFICE PERSONNEL TRANSACTIONS**

<u>Actions Requested</u>: Consider ratification of the personnel registers and other actions of the institutions as delineated below:

#### 1. University of Iowa

- a. Register of Personnel Changes for April 2007. The register included two additional faculty promotion and tenure actions.
- b. Appointments: DOUGLAS TRUE as Treasurer and SUSAN KLATT as Secretary for the fiscal year beginning July 1, 2007, in accordance with <u>lowa Code</u> §262.9.
- c. Retirement: PATRICIA CAIN, Vice Provost, effective July 1, 2007. The following changes will occur in the Office of the Provost. Lisa Troyer, Administrative Fellow in the Office of the Provost and Professor of Sociology, will become Interim Associate Provost for Academic Administration, effective July 1, 2007. She will assume responsibility for academic program development and review, accreditation, decanal review procedures, and the assignment and management of academic space. This will be a one-year, interim appointment. The position of Vice Provost will not be filled during this interim. Normally, the Vice Provost represents the Provost's Office at meetings or events when the Provost is unable to be present. Thomas Rocklin will take over this responsibility, and his title will be changed to Senior Associate Provost to reflect this new change.
