**APPOINTMENTS AND OTHER PERSONNEL ACTIONS**

**Actions Requested:** Consider approval of the appointments and other actions as delineated below:

**1. UNIVERSITY OF IOWA**

- a. Reappointments: DOUGLAS TRUE as Treasurer and SUSAN KLATT as Secretary for the fiscal year beginning July 1, 2012, in accordance with Iowa Code §262.9.
- b. Appointment: RAUL CURTO, Associate Dean in the College of Liberal Arts and Sciences, as Interim Dean of the College of Liberal Arts and Sciences, effective July 1, 2012, through August 14, 2012, at an annual salary of \$293,116.
