**PERSONNEL APPOINTMENTS**

**Actions Requested:** Approve the appointments as delineated below:

**1. UNIVERSITY OF NORTHERN IOWA**

- a. Appointment: NICK RAFANELLO as Executive Director for Housing & Dining at an annual salary of \$125,000 effective May 1, 2021.
- b. Reappointment: TONYA GERBRACHT as Secretary and Treasurer for the fiscal year beginning July 1, 2021, in accordance with Iowa Code §262.9(2).
- c. Appointment: PATRICK PEASE as Interim Provost and Executive Vice President for Academic Affairs at a monthly salary of \$22,000 (annualized to \$264,000) effective June 1, 2021 through July 11, 2021.
- d. Appointment: JOSE HERRERA as Provost and Executive Vice President for Academic Affairs at an annual salary of \$275,000 effective July 12, 2021, for a three-year appointment term.

**2. UNIVERSITY OF IOWA**

- a. Reappointment: TERRY JOHNSON as Treasurer for the fiscal year beginning July 1, 2021, in accordance with Iowa Code §262.9(2).
- b. Reappointment: SUSAN KLATT as Secretary for the fiscal year beginning July 1, 2021, in accordance with Iowa Code §262.9(2).
- c. Corrected Appointment: JOHN KELLER as Interim President of the University of Iowa, at a salary of \$400,000, effective May 17, 2021 through such time as the successor president of the University of Iowa assumes the position.

**3. IOWA STATE UNIVERSITY**

- a. Appointment: BONNIE WHALEN as Secretary for the fiscal year beginning July 1, 2021, in accordance with Iowa Code §262.9(2).
- b. Appointment: PAMELA ELLIOTT CAIN as Treasurer for the fiscal year beginning July 1, 2021, in accordance with Iowa Code §262.9(2).
- c. Appointment: HILARY SEO as Dean of Library Services at an annual salary of \$266,000 effective May 10, 2021.

**4. IOWA SCHOOL FOR THE DEAF**

5. IOWA EDUCATIONAL SERVICES FOR THE BLIND AND VISUALLY IMPAIRED

**Background:** Iowa Code §262.9(2) requires that the Board appoint institutional secretaries and treasurers annually. Iowa Administrative Code 281—102.5(1) requires that the Board appoint Level 1 child abuse investigators and alternates at the two special schools annually.

Board of Regents Policy 2.1.C.ii requires approval by the Board of appointments of provosts, vice presidents and directors of major units and comparable positions at the special schools. Other appointments are presented for the Board's information.
