Board President Report

President Richards read a statement:

Last month, I announced that the Board will establish a working group to study Diversity, Equity and Inclusion efforts at Iowa's public universities.

Regents Barker, Lindenmayer and Rouse will lead this working group. They have been working with Board office staff to come up with a structure and process for how the comprehensive review will proceed. They have also been having conversations with the university presidents.

While the review has not yet started, and the specifics are still being worked out, here is what I can share at this point:

We expect the review to take several months, and likely stretching into the fall semester. There will be multiple meetings.

Faculty, staff and students from the universities will be included in the process.

There will be an opportunity for anyone, whether it be members of the campus community or general public, to provide feedback to the working group via a web-based form.

When the working group has completed its review, it will present its findings and any recommendations to the full Board of Regents at one of the Board's public meetings. Tentatively, we have identified November 2023 as the meeting when the working group will make its presentation, but this could change.

This is a very important topic, and the Board looks forward to letting the working group create the process and do its work, and present back to the Board its findings.

President Richards read the following proclamation for Regent Nancy Boettger:

WHEREAS, Nancy Boettger was appointed to the Board of Regents by Governor Branstad for a term beginning May 1, 2017, and her term will end on April 30, 2023; and

WHEREAS, she has served as Chair of the Board of Regents Academic Affairs Committee, which provided oversight of academic programs, faculty activities, admissions standards, and student success benchmarks; and

WHEREAS, during her time on the Board, successful searches were conducted for institutional leaders at Iowa State University and the University of Iowa, resulting in the hiring of outstanding presidents at each university;

WHEREAS, during her time as a Regent, the Board completed a historic 50-year, \$1.165 million public-private partnership (P3) with the University of Iowa's utility system, and she also served as a member of the three-person group that reviewed and approved strategic initiative projects for the university funded from the P3 endowment; and

WHEREAS during her tenure, the Board approved hundreds of millions of dollars in capital projects at the Regents universities, including academic, student residential, and health care construction and improvements; and

WHEREAS, she was a member of the Board's free speech working group, which met in 2020 and 2021 and provided recommendations adopted by the Board to improve and strengthen the universities' efforts in free speech; and

WHEREAS, she served as a commissioner of the Midwestern Higher Education Compact, an organization of 12 member states that strengthens postsecondary education through cost-saving initiatives and policy solutions informed by research and the expertise of regional leaders; and

WHEREAS, she served as a member of the Board's Tuition Task Force in 2017, which involved multiple public meetings to discuss tuition and funding at the public universities; and

NOW THEREFORE, BE IT RESOLVED that the Board of Regents, State of Iowa expresses its deep gratitude to Regent Boettger for her expertise and dedication, and publicly acknowledges her for her extraordinary service and contributions to the Board of Regents, its institutions, students, families, and all Iowans.

Regent Boettger thanked the Board, noting that her time of service had been a pleasure and a privilege and that Iowa State University was what had drawn her to the state of Iowa.

Reports from Institutional Heads

President Wintersteen, President Wilson and President Nook presented updates on their respective institutions.

ISU Research Presentation – Antimicrobial Resistance

President Richards recognized Dr. Peter Dorhout, VP for Research at ISU, who introduced Dr. Paul Plummer, professor and Anderson Chair of Veterinary Sciences at Iowa State. Plummer, executive director of the National Institute of Antimicrobial Resistance Research and Education and chair of the Presidential Advisory Council for Combating Antimicrobial Resistant Bacteria, presented his research on Antimicrobial Resistance.

FY 2024 Salary Policies

President Richards recognized Board Counsel Aimee Claeys, who introduced representatives from faculty and staff groups who are not organized for collective bargaining purposes to present to the Board. Presenters included Ana Rodríguez-Rodríguez, president of the UI Faculty Senate, UI Staff Council President Jackie Kleppe, ISU Faculty Senate President Jon Perkins and UNI Professional and Scientific Council President Kristina Kofoot.

Collective Bargaining Agreements

President Richards recognized Board Counsel Aimee Claeys and Associate Board Counsel and Director of HR and Merit Systems Kristin Bauer. Bauer presented collective bargaining agreements with the Board's various bargaining units.
