# UNIVERSITY OF IOWA REQUEST FOR EMERGENCY CONTRACTING AUTHORIZATION

<u>Action Requested</u>: Consider recommending to the Board ratification of the Chief Operating Officer's actions related to the use of emergency procedures as described below to repair fire damage on June 11, 2017 at the Bowen Science Building to its pre-incident condition to ensure continuity of function and protect the building and its contents.

**Executive Summary:** On June 22, 2017, Assistant Director of Facilities John Nash received a memorandum from University of Iowa Design & Construction Director Sadie Greiner requesting authorization to invoke <u>Iowa Code</u> subsection 262.34.2 to institute emergency procedures to award a sole source contract to Merit Construction Company of Cedar Rapids (see Attachment A).

Chief Operating Officer Braun made a finding of the need to institute such emergency procedures and authorized the use of the sole source contract (See Attachment B).

Background: In 2009, the following subsection (subsection 2) was added to lowa Code 262.34.

"2. Notwithstanding subsection 1 [competitive bidding requirements], when a delay in undertaking a repair, restoration, or reconstruction of a public improvement might cause serious loss or injury at an institution under the control of the state board of regents, the executive director of the board, or the board, shall make a finding of the need to institute emergency procedures under this subsection. The board by separate action shall approve the emergency procedures to be employed."

Iowa Code subsection 262.34 states:

"2. Notwithstanding subsection 1, when a delay in undertaking a repair, restoration, or reconstruction of a public improvement might cause serious loss or injury at an institution under the control of the state board of regents, the executive director of the board, or the board, shall make a finding of the need to institute emergency procedures under this subsection. The board by separate action shall approve the emergency procedures to be employed."
