#### **Efficiencies and Reallocations at Public Universities**

President Allen, President Harreld, and President Nook discussed savings and efficiencies efforts at their respective university.

In response to a question from Regent McKibben, President Allen explained how TIER savings are reallocated.

In response to a question from Regent McKibben, President Harreld elaborated on the importance of student financial aid as it relates to SUI's long-term plan, commitment to first-generation students, and support mechanisms.

In response to a question from President Pro Tem Cownie, President Harreld discussed the retention rate of first generation students as well as how much these students spend for tuition on average.

In response to question from Regent Boettger, President Harreld discussed SUI's four-year graduation rates as compared to higher four-year graduation rates at peer institutions.

Regent McKibben expressed appreciation for the cultural changes and collaboration at the three universities as a result of the TIER process.

President Nook talked about quality and efficiency improvements at UNI.

In response to a question from President Richards, Regent McKibben said the total estimated savings of TIER is between \$55 and \$60 million.
