FACULTY PRESENTATION: PRECISION CANCER MEDICINE

Carver College of Medicine Dean Debra Schwinn gave a brief overview of precision medicine and introduced: (1) Holden Comprehensive Cancer Center Chair and Director and Professor of Internal Medicine Dr. George Weiner; (2) Carver College of Medicine Department of Pathology Professor and Chair and Department Executive Director Dr. Nitin Karandikar; and (3) Carver College of Medicine Department of Pathology Clinical Associate Professor and Molecular Pathology Director Dr. Aaron Bossler.

The group gave a presentation on precision cancer medicine.

In response to questions from Regents Bates, Sahai, and McKibben: (1) Dr. Weiner confirmed that physicians around the state can utilize the University of Iowa's laboratory services; (2) Dr. Bossler elaborated on how long the University has been doing molecular targeted testing; and (3) Dr. Weiner explained the relationship with engineering and informatics specialists to develop software systems that analyze data.

Chair Andringa thanked them for their presentation.
