This letter provides information about the meeting of the Board of Regents on April 1 that will be held virtually. With the current spread of coronavirus, we are following current guidance of not holding large gatherings in person and will conduct our business online. Below are some specific individual items that are on the agenda:

Dr. Brooks Jackson and Suresh Gunasekaran from the University of Iowa Hospitals and Clinics will provide an update to the Board on the Coronavirus.

Iowa State University will present the project budget for the construction of the new Veterinary Diagnostic Laboratory (VDL) on ISU's College of Veterinary Medicine campus. It will be a new, two-story, stand-alone 72,540 square foot facility with a project budget of \$75 million, funded by a combination of state appropriations, private gifts and university funds.

The Board will receive the annual reports on faculty tenure and promotion and tenure actions. The reports include approval of promotion and tenure actions for the academic year beginning this fall. The University of Iowa is requesting approval of 147 promotion and tenure actions; Iowa State University is requesting 98; and the University of Northern Iowa is requesting 32. In 2019-20, the number of tenured faculty at the universities was 2,495, a one percent decrease from the previous year. The number of tenure-track faculty was 782, a less than one percent decrease from the previous year.

Board committees will have many other items of business to consider, including:

- The Property and Facilities Committee, chaired by Regent Dakovich, will meet at 9:00 a.m. In addition to the previously mentioned Veterinary Diagnostic Laboratory, the committee will consider seven other construction projects, with an estimated total cost of \$63.8 million. The committee will also consider one property sale and several leases and easements.
- The Academic Affairs Committee, chaired by Regent Boettger, will meet at approximately 9:30 a.m. They will receive the annual diversity report, a request for a new program, the above mentioned tenure report and requests, and a request for honorary degrees.
- The Investment and Finance Committee, chaired by Regent Barker, will meet at approximately 10:45 a.m. It will receive a request for modifications of financial institutions, brokerage firms and money market mutual funds; the 2019 fourth quarter investment and cash management report; and a faculty presentation on investment strategies.
- The Audit and Compliance Committee, chaired by Regent Dunkel, will meet at approximately 11:30 a.m. The committee will receive state audit reports and internal audit reports.
- The University of Iowa Hospitals and Clinics Committee, chaired by Regent Bates, will meet at 12:30 p.m. The committee will receive the current operating and financial performance report and UIHC will present its proposed rate increase for FY2021.

Other agenda items for the Board include:

- Receiving reports from the institutional heads at the public universities and special schools.
- Elect a Board of Regents President and President Pro Tem for the period from May 1, 2020 through April 30, 2022.
