**Discussion Questions:** 

Emily: How many students are likely to be affected by changing requirement to include family farms and small businesses in EFC – College Aid is not able to calculate this

Ann Marie – do you know if there will be a revisiting of other aid programs based on how they are impacted due to these changes?

Laura – when are these changes effective? Form released December 2023 for Fall 2024 student enrollment

Rachel – question about proposed changes to state financial aid programs; college aid has begun conversations with legislators

Kudos and appreciation for the presentation

#### Emily Cataldi and Rachel Boon presentation on E-transcript gateway

Mark question: how difficult is the issue of standardizing GPA?

Will need college support once it moves past the pilot phase with high schools

Starting with PDF will send via email and then data feed delivery mechanism

Working on standards-based grading which is very complex and variable across institutions

PESC standards used when developing e-transcript which should help with data feed

Will schools be required to participate/submit data? This will be opt-in; if schools don't publish a particular filed (such as class rank), it will not appear on transcript

Can add additional information to e-transcript over time, such as how a school does standards-based grading

How will you be working with K12 private schools? They will be welcome to opt-in, but the state would need access to the data; about half of the private colleges in the high school already submit

Looking to roll out pilot in the next couple of weeks; no one nationwide has done a homegrown e-transcript system like this, so we will have to see how long it takes to roll this out with each individual school

Emily: what awareness do the college-level admission/registrar staff have of this? Have talked about in a number of key spaces; communications coming out soon to all admission staff and high schools; communication team has planned out communications with various stakeholders, but they would also ask that we all help spread the word; but they also do not want to over-promise in terms of timeline and when it will be available

#### For the Good of the Order updates

Expectations around licensure and disclosure -Regents and DOE are trying to bring together a group across the state to see if we can help create efficiencies; significant administrative work will be required

This will be Kristie's last meeting as chair; University of Iowa president (Barbara J. Wilson) will take over as chair; Zoom meeting of large group is being planned in the Fall; will circle back on professional licensure conversation at that meeting

Regent Nancy Boettger will be rolling off the Board of Regents as of April 30, a new regent will be assigned to the Iowa Coordinating Council for Post-High School Education (ICCPHSE). Thank you, Nancy, for your service!
