### **7. Letter from Incoming Chair John Sellars to Membership—Diana Gonzalez**

### **9. Membership for 2015-2016—Diana Gonzalez**

#### 10. Fall 2015 Enrollment Report Data Collection—Diana Gonzalez

John's letter will include a reminder for institutions to participate in the ICCPHSE fall enrollment report which is important for policymakers. Data is due by the end of September, and the results will be finalized in October.

#### 11. Fall 2015 Veterans Enrollment and Credit Report Data Collection—Jeremy Varner

Jeremy reported on veteran data reporting mandated as part of the Home Base Iowa initiative. Home Base Iowa is intended to help veterans make a smooth transition to civilian life in Iowa. The data reporting requirements support efforts to ensure veterans receive appropriate credit for prior military education, training, or experience. Data reporting will be at the aggregate level on five data elements and will include five fiscal years of data. All public universities, community colleges, and Iowa Tuition Grant eligible independent colleges and universities are mandated to report. The reporting process was developed by an accountability subgroup that included representation from community colleges and public universities. These institutions piloted the data reporting in spring 2015. The Iowa Department of Education is coordinating data reporting, but the final report will be a product of the ICCPHSE. Guidance has been provided to institutions and the deadline for data reporting is October 1, 2015. The department will bring summative data to the ICCPHSE at its fall meeting and distribute the final report electronically in November for review and approval. The final report will be provided to the Governor and General Assembly prior to December 15, 2015.

#### 12. Home-Base Iowa (HBI) Initiative—Multi-State Collaborative on Military Credit Report Data—Diana Gonzalez

Diana reported that these are two distinct efforts; there is much overlap. Primarily with both of them, what protocols are in place at our postsecondary institutions to award credit for military experiences? How many credits are awarded to veterans to apply to their major?

The Midwestern Higher Education Compact (MHEC) will assist an interstate partnership of 13 states to facilitate processes which assist institutions to determine credits related to military training and experience. States will exchange information and share best practices in the areas of articulation of credit, certification/licensure, communications, and technology. The purpose is to assist states in adopting best practices to support veterans.

The overlap with HBI is so significant; we want to blend the two as much as possible. Diana serves on the MHEC Steering Committee as Iowa's liaison. There are representatives from all sectors on the HBI Advisory Team. The protocol to be used at each of the institutions is to review the veterans' credits. Diana asked if it is possible within your institution to be more uniform in awarding credit.

ICCPHSE Meeting Minutes – Wednesday, April 15, 2015

**1. Welcome**

The Iowa Coordinating Council for Post-High School Education (ICCPHSE) met on Wednesday, April 15, 2015, at 10:00 a.m. at the University of Northern Iowa. Chair Bill Ruud welcomed the Council members and guests to the meeting.

**2. Call to Order and Introductions**

Chair Ruud called the meeting to order, and then the Council members and guests introduced themselves. The following individuals were present:

### **3. Approval of Meeting Minutes—Jeremy Varner, Recording Secretary**

Jeremy Varner presented the minutes from the October 7, 2014, ICCPHSE meeting for approval.

**Action:** Diana Gonzalez moved and Dan Kinney seconded for approval of the minutes as presented. Motion passed.

### **4. Treasurer’s Report—Diana Gonzalez on behalf of John Sellars, Treasurer**

Diana Gonzalez presented the treasurer’s report on behalf of John Sellars. Gonzalez presented a statement of the Council’s income and expenditures through March 2015. She indicated Sellars recommended continuing dues for 2015-2016.

**Action:** Dan Kinney Sr. moved and Jay Nardini seconded for approval of continuing dues for 2015-2016. Motion passed.

Diana explained expenditures, including the Way-Up Conference contribution.

**Action:** Dan Kinney moved and Diana Gonzalez seconded for approval to contribute \$500 to the Way-Up Conference. Motion passed.

**Action:** Jeremy Varner moved and Diana Gonzalez seconded for approval of the treasurer’s report as presented. Motion passed.

### **5. Campus Safety and Security Summit Update—Annette Lynch**

Annette Lynch, Professor and Director of the Center for Violence Prevention at the University of Northern Iowa (UNI), updated the Council on the Campus Safety and Security Summit. She provided the historical context and the center’s role in building capacity for public entities to address these issues.

She explained efforts to address campus safety issues at UNI and statewide, including planning for a state conference on the issue involving public universities, community colleges, and private and independent colleges and universities. She indicated that campuses need guidelines, but autonomy to

create their own policies and prevention programs. Areas of focus include: bystander intervention training; investigating sexual misconduct and adjudication; and policy development. The summit will be held on October 28, 2015, at the FFA Building on DMACC's Ankeny campus.

Diana Gonzalez indicated the goal is for a statewide cross-sector summit to help institutions be prepared to address incidents. The planning team is in place and others can be added, if interested. All higher education institutions are encouraged to send teams with broad campus representation.

#### **6. M-SARA Update from the Iowa College Student Aid Commission (ICSAC)—Julie Leeper**

Julie Leeper, Iowa College Student Aid Commission (ICSAC), explained the status of efforts related to the State Authorization Reciprocity Agreement (SARA). She provided the historical context for SARA which was developed to address U.S. Department of Education state authorization regulations issued in 2010 and with an effective date of July 1, 2015. Under the rules, postsecondary institutions must be authorized in states where students are enrolling in online courses.

Obtaining authorization in all states individually is expected to be exceedingly expensive and labor intensive. SARA addresses the patchwork of state rules and fees by establishing regional compacts with the goal of requiring only a single state authorization process. Under M-SARA, Iowa institutions would register only through ICSCAC. Iowa has been working with the Midwest Higher Education Compact on M-SARA participation for two years. Iowa is currently not a member due to issues with consumer protections.

The Attorney General's Office has wanted to ensure the consumer protections, particularly tuition refund policies, remain in place while MHEC demands standardization of registration processes precluding these policies. Iowa passed legislation to join M-SARA last year, but was rejected by MHEC due to the consumer protection policies. There is work on an agreement between the Governor's Office, Attorney General's Office, and college presidents. The Governor proposed a state fund to cover tuition refunds if the policy is removed from state authorization, but the Attorney General's Office hasn't committed and is exploring the issue further. College presidents plan to approach legislators about the issue. Because of the impending July 1 deadline, the issue is pressing. A total of 35 states are expected to participate in SARA by the end of the fiscal year.

#### **7. Home-Base Iowa Reporting Update—Jeremy Varner**

Jeremy Varner updated the Council on the status of Home Base Iowa reporting. He noted Home Base Iowa is a broad effort to make Iowa more attractive to veterans and includes a package of incentives. There is an educational component related to resident tuition and the Certified Higher Education Academic Military Partner (CHAMP) program, making higher education institutions more attractive to veterans. One piece of that is helping matriculating students obtain credit for prior military education or experience. Jeremy noted that at previous meetings, the Council discussed efforts to work on that issue. Data reporting is one component of that work.

Jeremy noted that Senate File 303, passed into law during the 2013 legislative session, which mandates Iowa community colleges, public universities, and Iowa Tuition Grant eligible independent colleges and universities report data on the awarding of postsecondary credit for prior military training and experience. The requirement is that by fall 2015, institutions will report not only on data elements for the prior year, but the five prior years which is unusual and burdensome.

The department is coordinating the data reporting effort and recently conducted a pilot with public universities and community colleges to make sure data elements are properly defined and the reporting structure works appropriately. A Home Base Iowa Education Working Group subgroup developed recommendations for how the data would be collected including having colleges report only aggregate data (no unit records or personally identifiable data). The group also recommended broadening the definition of veteran and department proposed, and the Governor signed legislation which addresses the issue. The data elements include the number of veteran students enrolled, the number receiving credit for military education or experience, the average number of credits received by the student, and the number of credits applying toward students' majors. The subgroup also discussed adding other elements to provide a fuller picture, although that will be discussed further.

Jeremy indicated the formal reporting of metrics will begin in the fall of 2015, although institutions are required to report on fiscal years 2011-2015 as well. The report will go to the Governor and General Assembly. The DE will work to explain what the data means and doesn't mean in conjunction with the working group and will manage the reporting process to ensure consistency. The ICCPHSE will be the body approving and issuing the report – similar to how it does the fall enrollment report annually.

#### **8. Multi-State Collaborative on Military Credit Update—Diana Gonzalez**

Diana Gonzalez provided an update on the Multi-State Collaborative on Military Credit (MCMC), including an update on related efforts to address the issue of awarding college credit for military education including the February 6 meeting. She noted that 160 people attended the February 6 meeting with Michelle Spires from American Council on Education (ACE) and that teams learned about the ACE process. She noted that MHEC created the MCMC to look at the issue further. The MCMC is a 13-state collaborative funded by a Lumina Foundation grant. Diana is the liaison and she is coordinating development of a state plan. She is seeking feedback from institutions about their institutional needs to help inform the work.

#### **9. National Governor's Association—America Works: Education and Training for Tomorrow's Jobs—Jeremy Varner, Paula Nissen, and Ryan Murphy**

Jeremy Varner provided information about the National Governor's Association (NGA) Talent Pipeline Policy Academy. He noted the effort was rolled out by NGA a year and a half ago and Iowa was one of eight out of 26 states to receive a grant to advance innovative education and workforce development initiatives. Teams of state leaders including the Governor, President Ruud, Chancellor Duree, and state agency leaders started working on how to enhance the state's educational system's alignment with economic need.

He indicated the big picture goal is to establish priorities and develop policy recommendations – an action plan for significant improvements in how the state's education and workforce training systems align with the needs of the economy. He noted that globalization and technological change mean the jobs being created today require a higher skill level than in the past. When demand for skilled labor outstrips supply, economic growth is hampered. At the same time, many Iowans remain unskilled with economic insecurity and lower than we'd like workforce participation rates. At the current rate, the issue will worsen before it improves and a more credentialed workforce is the key to future prosperity. The vision of the group is to increase the percentage of Iowans with a postsecondary credential with labor market value – particularly in areas of high demand.

Jeremy noted the NGA project is led by a team with representatives from the Iowa Economic Development Authority (IEDA), Iowa Department of Education (DE), Iowa Workforce Development (IWD), Board of Regents, community colleges, Iowa College Student Aid Commission (ICSAC), and Science, Technology, Engineering, and Mathematics (STEM). Beyond that group, a more inclusive steering committee has been established with broader representation. Jeremy also noted how the NGA efforts tie to Workforce Innovation and Opportunity Act (WIOA) implementation, secondary career and technical education (CTE) reform, and other important efforts.

Jeremy noted the DE has a number of efforts underway aimed at closing the skills gap and enhance the alignment of educational programming with economic demand and providing useful data is among them. One project is to build a system to provide policymakers with community college education and employment outcomes and community college leaders with actionable data to support program planning and improvement. Jeremy explained how the DE and IWD have partnered to develop and implement a community college student outcome reporting system. The system supports federal program accountability, state program accountability, and new reporting which helps to describe CTE program efficacy. He noted the goal is to provide state level information, but also customized reports to support local decision-making to drive real change. The system utilizes community college administrative records, national student clearinghouse, Iowa unemployment insurance records, national Unemployment Insurance (UI) records through the Wage Records Interchange System (WRIS), and sometimes the Federal Employment Data Exchange System (FEDES) records.

Paula Nissen and Ryan Murphy explained the system in further detail, planned next steps, and opportunities for other postsecondary institutions.

Jeremy also explained changes to the DE process for program approval which includes both an intent and approval phase. The process isn't analogous to the ICCPHSE process, but has parallels. He explained enhancements to the DE's process with regard to notices of intent, labor market information expectations and guidance, and the implementation of a web-based program and common course numbering management system.
