The Board of Regents, State of Iowa, will meet for a Strategic Planning session on Thursday, October 30, 2008, beginning at 8:30 a.m., in the Uelner Executive Board Room of the Alumni Center at Iowa State University, Ames, Iowa. The specific purpose of the session is to begin the process for developing a long-term Board of Regents Strategic Plan.

The Board's discussion will be facilitated by Mr. Dennis Jones, President of the National Center of Higher Education Management Systems (NCHEMS), a nonprofit research and development center founded to improve strategic decision making in institutions and agencies of higher education. Mr. Jones is a well-known expert on higher education strategic planning, with 30 years of experience consulting with hundreds of public and private institutions and state higher education agencies in virtually all 50 states, including Arizona, Kentucky, Texas, Minnesota, and Nevada, as well as the Education Commission of the States.

The morning session on October 30 will be held with the Board of Regents and the Board staff. The institutional heads and university provosts will join the afternoon session.

The Board of Regents is a group of nine citizen volunteers who govern the state's three public universities and two special K-12 schools – the Iowa School for the Deaf and the Iowa Braille and Sight Saving School – through policymaking, coordination, and oversight.
